**What is AGMT?**

The Architectural Glass and Metal Technician (AGMT) program is a personnel certification process featuring a third party, independent assessment of a glazier's knowledge and ability. AGMT tests experienced glaziers' fundamental knowledge, skills, and abilities through written and hands-on testing. It also comes with an emphasis on minimizing defects and failures.





**What is NACC?**  
The North American Contractor Certification (NACC) Program provides Architectural Glass and Metal Contractors with certification recognition through a professionally administered, 3rd party assessment, as a means of creating a baseline for competency and adherence to industry-accepted guidelines.



**What's in the program?**

The NACC Program requirements are broad in scope to encompass the AG&M contractor organization. A detailed annual assessment is performed with focus & evaluation on these key areas:

-  Company Business Practices
-  Safety
-  Quality Management Systems
-  Contract Administrative Processes
-  Glazing Processes

**What's in the program?**

The AGMT Certification Program is designed to provide an independent assessment (written and practical) of the knowledge, skills, and abilities of the experienced glazing technician in:



Glazing theory and the ability to practically apply that knowledge



Demonstration of competency in interpreting construction drawings and ability to lay out and install various types of glazing systems for glass and architectural panels



Utilization of tools of the glazing trade and demonstration of safe work practices



Application of sealants, gaskets, and barriers to weatherize those systems



Understanding and possessing a working knowledge of quality controls

**Why does contractor certification matter?**  
Having an efficient and professional installation of glazing product is crucial in today's very competitive environment. Every stakeholder involved in the supply chain benefits from competency. The NACC program is built to recognize the companies that are able to properly satisfy the installation needs and to give peace of mind to the building owners, design professionals, and general contractors.

**What sort of oversight is there for NACC?**  
The NACC Program is formally accredited by the American National Standards Institute (ANSI) to the globally-recognized ISO/IEC 17065:2012 Standard. As part of ANSI's ongoing annual accreditation process, an assessor witnesses the administration of the NACC Program onsite, at contractor's organizations, adding another layer of accountability.
